ORDINANCE NO. 72-2

AN ORDINANCE FIXING THE SALARY OF
THE MAYOR AT \$150.00 PER ANNUM

The Borough Council of the Borough of New Berlin, Union County, Pennsylvania, hereby enacts and ordains as follows:

Section 1. The salary of the Mayor of the Borough of New Berlin is hereby fixed at One Hundred Fifty Dollars (\$150.00) per annum, commencing with the calendar year 1972.

Section 2. The aforesaid salary shall be paid from the Borough treasury in quarterly installments on warrants authorized by Council.

Section 3. Any salary paid pursuant to this Ordinance shall be in lieu of all costs and fees allowed a mayor, in accordance with Section 1026 of the Act of February 1, 1966, P.L. (1965) No. 581, 53 P.S. §46026.

Section 4. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

Section 5. This ordinance shall take effect immediately upon enactment.
