

RESOLUTION NO. 2021-4

A RESOLUTION SETTING THE SCHEDULE OF FEES CHARGED BY THE BOROUGH OF NEW BERLIN FOR PERMITS/LICENSES, ORDINANCE VIOLATIONS, AND FEES AND COSTS WITHIN THE BOROUGH OF NEW BERLIN UNION COUNTY, PENNSYLVANIA

WHEREAS, on the 9th day of June 2021, the Borough Council enacted a Resolution establishing the authority of the Council to periodically set a Schedule of Fees for the Borough of New Berlin; and

WHEREAS, the said Resolution can be amended by the Borough Council from time to time; and

WHEREAS, it is the desire of the Borough Council to set a fee schedule.

BE IT RESOLVED AND ENACTED by the Council of the Borough of New Berlin, Union County, Pennsylvania, that hereby establishes the following Schedule of Fees to be paid to the Borough in accordance with the ordinances of the Borough of New Berlin:

Fees for the activities and services performed in carrying out responsibilities under the International Property Maintenance Code as permitted by Section 103.5 of the Code -

1. CKCOG - \$64.00 per hour
2. Street Department Personnel – hourly rate of each employee who performed duty
3. Office Personnel – hourly rate of each employee who performed duty
4. Police Department Personnel - hourly rate of each employee who performed duty
5. Solicitor – hourly rate
6. The reasonable out-of-pocket charges, costs, expenses, commissions and fees, such as but not limited to, postage, title searches, prothonotary fees, all costs associated with prosecution, and sheriff fees shall be added to the above amounts.

Landlord Registration	\$25.00 per unit, per year – exemption for life estates
Solicitation Permit	\$200.00 per week
Sidewalk permit	No charge
Zoning Permit	\$15.00
	\$450.00 if variance or special exception hearing needed.
Accident Report	\$15.00

Parking Tickets \$10.00 – if paid within 5 days

 \$25.00 if paid from day 6 through day 15

 After 15 days a citation is filed in the District Justice Court \$50.00 to \$600.00 fine plus cost of prosecution.

Returned Check Fee \$30.00




